

AN ORDINANCE AMENDING ELECTRICAL RATES FOR ENERGY SOLD BY THE MUNICIPAL ELECTRIC SYSTEM OF THE CITY OF RUSSELL, KANSAS, AND AMENDING SECTIONS 15-318 THROUGH 15-329 AND SECTION 15-332 OF THE CODE OF THE CITY OF RUSSELL

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF RUSSELL, KANSAS:

Section 1. Subpart(b) of Sections 15-318 through 15-329 and subpart (b) of Section 15-332 of the Code of the City of Russell, establishing the rates, as provided in said subpart (b) of each Section, for the existing classes of services are hereby amended to read as follows:

a. Section 15-318(b) on Residential Service Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$23.00
- 2. Energy Charge9.365¢ per KWH

b. Section 15-319(b) on Rural Residential Service Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$23.00
- 2. Energy Charge10.90¢ per KWH

Section 15-320: (Intentionally left blank, rate structure no longer in effect.)

c. Section 15-321(b) on Commercial Lighting, Power Service, Inside Corporate Limits, Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$35.00
- 2. Energy Charge9.614¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ per horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

d. Section 15-322(b) Commercial Lighting, Power Service, Outside Corporate Limits Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$35.00
- 2. Energy Charge10.414¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ per horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

e. Section 15-323(b) City Oilfield Pumping Service Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$45.00
- 2. Energy Charge9.121¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ per horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

f. Section 15-324(b) Rural Oil Field Pumping Service Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$45.00
- 2. Energy Charge10.610¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

g. Section 15-325(b) City Industrial Manufacturing Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$45.00
- 2. Energy Charge9.9948¢ per KWH

A minimum charge of not less than 50¢ per KVA of connected load will be made in lieu of the Energy Charge when the customer's Energy charges is less than this minimum charge.

h. Section 15-326(b) Rural Industrial Manufacturing Rate is amended to:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$45.00
- 2. Energy Charge11.4948¢ per KWH

A minimum charge of not less than 50¢ per KVA of connected load will be made in lieu of the Energy Charge when the customer's Energy charges is less than this minimum charge.

i. Section 15-327(b) Rates More Than Three Miles Outside City Limits; Residential Service is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

- 1. Customer charge\$23.00
- 2. Energy Charge9.365¢ per KWH

j. Section 15-328(b) Rates More Than Three Miles Outside City Limits; Business Service Energy Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

Customer charge	\$35.00
Energy Charge	9.614¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

k. Section 15-329(b) Rates More Than Three Miles Outside City Limits; Oil Field Pumping Service and Other Service is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

1. Customer charge	\$45.00
2. Energy Charge	9.121¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

l. Section 15-332(b) Large Power Service Rate is amended to read as follows:

b. Rates (Per Monthly Billing Cycle):

1. Customer charge	\$500.00
2. Energy Charge	4.51¢ per KWH
3. Demand Charge	\$17.38 per KW

A minimum charge of not less than the customer charge plus 50¢ per KVA of connected load will be made in lieu of the Energy Charge when the customer's Energy charge is less than this minimum charge.


The demand charge is based on the maximum 15-minute period of the customer's greatest use during the monthly billing period measured to the nearest KW.

Section 2. City Code Sections 15-318 through 15-329 and Section 15-332 on the Rates as set forth in subpart(b) to each section and as stated above are hereby amended upon the effective date of the rate changes stated below.


Section 4. This ordinance shall be in full force and effect after its passage and publication of the ordinance or a summary of the ordinance as provided by law, and shall be first effective for the sale of electric energy, billed with the September, 2023, utility billing.
