## ORDINANCE NO. 1919

AN ORDINANCE RELATING TO THE SALE AND USE OF ELECTRICAL ENERGY WITHIN AND OUTSIDE THE CORPORATE LIMITS OF THE CITY OF RUSSELL, KANSAS, SOLD BY THE MUNICIPAL ELECTRIC SYSTEM OF THE CITY OF RUSSELL, KANSAS, ESTABILSHING CLASSES OF SERVICE, FIXING THE GENERAL CLASSES OF RATES AND AMENDING SECTIONS 15-318 THROUGH 15-324 AND 15-327 THROUGH 15-329 OF THE CODE OF THE CITY OF RUSSELL.

## BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF RUSSELL, KANSAS:

Section 1. Sections 15-318 through 15-324 and 15-327 through 15-329 of the Code of the City of Russell, are hereby amended to read as follows:

Section 15-318: RESIDENTIAL SERVICE. This schedule applies only to services within the boundaries of the City. "Residential Service" is defined as service to residential premises for non-commercial and nonindustrial purposes used by the occupant of such premises for residential purposes. Commercial rates shall apply to any building used for both residential and commercial purposes, unless the residential service and commercial service are measured by separate meters.

- (a) Service under this schedule will be alternating current, 60 cycles, single or three phases, at the voltage as the City may have available for the service required.
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge ......\$10.00

Section 15-319: RURAL RESIDENTIAL SERVICE. The schedule applies to service only to property outside the corporate limits but within three miles of the City, which property, if it were inside such boundaries, would be eligible under the rate above set forth in Section 15-318 of this article.

- (a) Service under this schedule will be alternating current, 60 cycles, single or three phases, at the voltage as the City may have available for the service required
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge ......\$10.00
  - 2. Energy Charge ......11.650¢ per KWH

Section 15-320: (Intentionally left blank, rate structure no longer in effect.)

Section 15-321: COMMERCIAL LIGHTING, POWER SERVICE; INSIDE CORPORATE LIMITS. This schedule is applicable to any customer using electric service for lighting, heating, and small power for any business enterprise, institution, or public purpose located within the corporate limits of the City.

- (a) Service under this schedule will be alternating current, 60 cycles, single or three phase, at the voltage as the City may have available for the service required.
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge ......\$15.00
  - 2. Energy Charge .......10.364¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ per horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

Section 15-322: COMMERCIAL LIGHTING, POWER SERVICE, OUTSIDE CORPORATE LIMITS. This schedule is applicable to any customer using electric service for lighting, heating, and small power for any business enterprise, institution, or public purpose located outside the corporate limits, but within three miles of the City.

- (a) Service under this schedule will be alternating current, 60 cycles, single or three phase, at the voltage as the City may have available for the service required.
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge ......\$15.00
  - 2. Energy Charge .......11.164¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

Section 15-323: CITY OILFIELD PUMPING SERVICE. This schedule is applicable to separately metered customers located inside corporate limits of the City, using standard electric service for the purpose of oil and gas production.

- (a) Service under this schedule shall be three phase 240-480 volt, for all purposes, including lighting and power.
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge .....\$20.00
  - 2. Energy Charge ......9.871¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ per horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

(c) In the event, for economic or other viable reasons, that more than one oil well pump motor should be served by one meter, rate blocks shall be multiplied by the number of oil well pump motors connected to said meter.

Section 15-324: RURAL OIL FIELD PUMPING SERVICE. This schedule is applicable to separately metered customers located outside the corporate limits, but within three miles of the City, using standard electric service for the purpose of oil and gas production.

- (a) Service under this schedule shall be three phase 240-480 volt, for all purposes, including lighting and power.
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge .....\$20.00
  - 2. Energy Charge ......11.360¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

(c) In the event, for economic or other viable reasons, that more than one oil well pump motor should be served by one meter, rate blocks shall be multiplied by the number of oil well pump motors connected to said meter.

Section 15-327: RATES MORE THAN THREE MILES OUTSIDE CITY LIMITS; RESIDENTIAL SERVICE. This schedule applies only to residential service for property located more than three miles outside the boundaries of the city.

- (a) Service under this schedule will be alternating current, 60 cycles, single or three phases, at the voltage as the City may have available for the service required.
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge ......\$10.00

Section 15-328: RATES MORE THAN THREE MILES OUTSIDE CITY LIMITS; BUSINESS SERVICE. This schedule is applicable to any customer using electric service for lighting, heating, and small power for any business enterprise, institution, or public purpose located more than three miles outside the corporate limits of the City.

- (a) Service under this schedule will be alternating current, 60 cycles, single or three phase, at the voltage as the City may have available for the service required.
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge ......\$15.00
  - 2. Energy Charge ......10.364¢ per KWH

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

Section 15-329: RATES MORE THAN THREE MILES OUTSIDE CITY LIMITS; OIL FIELD PUMPING SERVICE AND OTHER SERVICE. This schedule is applicable to separately metered oil well pump motors located more than three miles outside the corporate limits of the City, using standard electric service for the purpose of pumping oil or gas wells, and all loads exceeding 50 horsepower or KVA.

- (a) Service under this schedule shall be three phase 240-480 volt, for all purposes, including lighting and power.
- (b) Rates (Per Monthly Billing Cycle):
  - 1. Customer charge ......\$20.00

A minimum charge of not less than \$1.00 per horsepower per month for the first 5 horsepower, and 50¢ per horsepower per month in excess of 5 horsepower or fraction thereof, will be made in lieu of the Energy Charge when the customer's Energy Charge is less than this minimum charge.

(c) In the event, for economic or other viable reasons, that more than one oil well pump motor should be served by one meter, rate blocks shall be multiplied by the number of oil well pump motors connected to the meter.

Section 2. City Code Sections 15-318 through 15-324 and Section 15-327 through 15-329 are hereby replaced upon the effective date of the rate change stated below.

Section 3. This ordinance shall be in full force and effect after its passage and publication of a summary of the ordinance as provided by law, and shall be first effective for the sale of electric energy, billed with the March 5, 2019, utility billing.
